FREQUENTLY ASKED QUESTIONS:

Does this protect against damaged tires?

Yes.

Will this provide a loaner truck while mine is being repaired?

No.

Can any portion of this be applied to my rent to purchase option if I decide to buyout?

No.

Does this apply to smoking fines?

No.

Does this protect me against mileage overage?

No.

Does this cover fuel contamination?

Yes, if contaminated due to water or solids in fuel from a retail purchased fuel station; however, if it is contaminated by operator (i.e. cross contamination of diesel and gas), then it's not covered.

Does this cover routine maintenance, i.e. oil change, etc?

No, but you can purchase our PPM program for preventative maintenance costs.

Enterprise has a \$1,000 deductible for each "occurrence". Will the PPP have a deductible?

No.

If damage involves an insurance claim, does this cover the deductible? If so, how much?

Yes, up to \$5,000 for total losses. No need to file an insurance claim for any reason other than a total loss.

Does this protect me from cleaning fees?

Yes.

Does this cover broken GPS devices?

Yes.

Does this cover upfit parts that have been damaged?

Yes, but not if missing or stolen.

Does this cover defective or broken keys?

Yes, but does not cover lost or missing keys.

Does this cover repairs while still on rent, or only when the unit is turned in and Off-Rented?

We will repair the unit while on rent if the damage affects serviceability. Certain damages, such as door dings, will be repaired after off-rented.

Is there a minimum rental time period required?

No.
